- \* All league teams start season with the Rob Mackey Labor Day Memorial Fall League Kickoff September 4 – September 7, 2020
- \* Open Roster until week # 4, then roster must be locked in for fall league year end tournament starting October 10 / 11, 2020
- \* Schedules based on each individual team's availability **(We make a reasonable effort to accommodate requests)**
- \* League games played Saturday or Sundays starting September 12 / 13, 2020
- \* 7–8 Game Season Schedule, **weather permitting**, in addition to 3 game format in Labor Day Kickoff. Double Elimination Playoffs after league schedule completed.
- \* All teams make random draw double elimination playoffs. Teams can play in either Saturday or Sunday or both days in playoffs.
- \* Double Elimination Playoffs begin October 10 / 11, 2020 **(weather permitting)**
- \* 1st & 2nd place teams in each age division will receive awards based on their finish in the playoffs
- \* Teams eliminated in double elimination round may continue to play in non-playoff games against other eliminated teams through October 24 / 25 weekend, **if requested and weather permitting.**
- \* Team age is based on the team's age division they were during the 2020 summer season
